

**The Dietz & Watson Real Philly Deli Hoagie Guide
Official Rules**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED. The Dietz & Watson Real Philly Deli Hoagie Guide (the "Promotion") begins at 9:00:00 AM Eastern Time ("ET") on March 18, 2019 and ends at 11:59:59 PM ET on August 5, 2019 (the "Promotion Period"). The Promotion contains a game of chance ("Sweepstakes"). The computer clock of the Sponsor (defined below) is the official time-keeping device in the Promotion.

- 1. ELIGIBILITY:** The Promotion is open only to legal residents of the 50 United States and the District of Columbia, who are 18 years of age or older as of date of entry. - 3. HOW TO ENTER THE PROMOTION:** To enter, visit a participating Deli Location (listed in Appendix A) and purchase a Dietz & Watson product during the Promotion Period. Upon purchasing a Dietz & Watson product, you will receive a unique code to redeem online at www.realphillydeli.com (the "Website"). Enter the Sweepstakes by completely entering your true and correct information on the registration form in the required fields (required fields include: Full Name, Address, City, State, Zip Code, Phone Number and Email Address). Upon registering, you will receive one (1) entry into the Sweepstakes ("Sweepstakes Entry"). **Limit of one (1) Sweepstakes Entry per person, per email address, per Entry Period.**

ALTERNATE MEANS OF ENTRY: To enter without purchase, hand-print your full name, full mailing address, email address, phone number, and birth date on a plain 3x5 inch paper.
